4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or National New Zealand Poison Centre New Zealand 0800 764 766.

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.
